The TANZ Foundation facilitates opportunities for a diverse range of youth to benefit from the life-changing experience that is sail training. Bursaries facilitate opportunities for disadvantaged or at-risk youth to build resilience and purpose through adventure, participation and challenge aboard a traditional tall ship; or for paid and volunteer crew to undertake practical and academic training towards formal maritime qualifications.

Bursaries are available to:

- young people aged between 14 – 25 years, for the purpose of joining an eligible development voyage
- tall ship crew seeking professional development via a recognised course or cross decking opportunity

Applications are open to Australian and New Zealand citizens or permanent residents and are considered on merit. The Bursary Panel's decision is final. A maximum of AUD \$1,000 will be awarded to each recipient.

TERMS AND CONDITIONS

Bursaries are awarded in accordance with the following terms and conditions:

- each Bursary is to a maximum value of AUD \$1,000, paid either directly to recipients or to an approved Operator by the TANZ Foundation in either Australian or New Zealand dollars;
- Bursaries are not transferable and must be used for the intended activity;
- recipients must be Australian or New Zealand citizens or residents and, if undertaking a youth development voyage, aged between 14 and 25 years on the date of the proposed activity;
- youth development voyages must be undertaken on an Australian or New Zealand Tall Ship operated by a financial Operator or Organisation Member of Tall Ships Australia and New Zealand;
- recipients agree to adhere to all Operator or program provider terms and conditions for the voyage, course or cross-decking opportunity;
- the TANZ Foundation takes no responsibility for activities undertaken using Bursary funds or travel to/from those activities. It is the recipient's responsibility to identify appropriate insurance cover;
- evidence of receipts for the payment of voyage fees to an eligible Operator, or of a recognised professional development course, or of airfares related to a cross-decking opportunity, must be provided to the TANZ Foundation prior to payment of the bursary;
- should the nominated activity not be undertaken, the bursary is to be repaid in full;
- all information provided will be processed and stored respecting the privacy of the applicant and shared only to the extent required to assess the application and process a bursary;
- the TANZ Foundation reserves the right to contact the relevant Operator to verify eligibility;
- recipients agree to provide written confirmation that the activity has been completed to the TANZ Foundation within 30 days of completion, including advice on any certification achieved;
- recipients agree to submit a written report (300 words) or short, shareable video to the TANZ Foundation within 30 days of completion. The report should describe the benefits gained / lessons learned from the experience and include up to five 'action' photographs attached as jpegs;
- recipients consent to reasonable use of their information in any promotional or publicity medium about the bursary and the recipient's participation in the nominated activity;
- recipients grant permission and give consent to Tall Ships Australia and New Zealand and the TANZ Foundation to use these reports, images and videos for promotional purposes and to publish these in both print and electronic media, including on the Internet and on social media platforms;
- recipients will be announced on the Tall Ships Australia and New Zealand website.

Claims for reimbursement must be accompanied by receipts in accordance with the terms and conditions. Should you be successful, banking details will be required to facilitate disbursement of funds.
